


Mike Williams | Bay of Plenty Branch Representative


**Shelley Duncan | Southern South Island Branch Representative**

Adoption of President's and Financial report: Moved Chris Davies/Neville Bamford. Seconded. Passed unanimously.

Life Member Warren Collett added acknowledgement of the work that the retiring board members Ross Bond, Ian Litchfield CCM, Michelle Campbell done collectively over a number of years and made special mention of Chris Davies, the retiring President, for his drive and determination in implementing the BMI Education Programme in New Zealand and his work on the executive for the last 11 years.

### Executive Officers report:

Des <u>Topp</u> indicated the pandemic will present many challenges that will demand constant business reassessment and planning. Issues forecast included

- Timetables disrupted
- Numerous event postponements
- Increased H&S security
- Implementation of Vaccine Passports will be an added financial burden to clubs
- Golf clubs will continue to be perceived to be a safe environment
- Gives rise to continued membership and fully vaxed green fee income growth.
- Sales will rebound as our borders open to international tourists.
- Monitoring Vaccination passports will come at a cost as extra manpower will be needed.

Members were asked to address the issues that arise collectively and work together as a team and were reminded to use the GMA support network where necessary.

Des welcomed the new members to the executive and he looks forward to working with them. Des acknowledged the financial support of Golf NZ and the work of Stephen Gee in the education space.

### Constitution:

Chris <u>Davies moved</u>, seconded Ian Litchfield CCM the following amendments to the Constitution and requested that the Constitution and Rules of the Association be amended by making the changes highlighted below be passed <u>en</u> bloc.

#### 4.0 Objects

New wording in bold

### The objects of the Association are:

- (a) To establish and maintain contact between all Members for the purpose of increasing the Members' knowledge of golf club administration and management
- (b) To provide quality service and delivery of activities, advocacy, and club management opportunities in New Zealand.
- (c) To have more members accessing our multi-level support offerings more often.
- (d) To encourage close co-operation, understanding, and initial assistance by the communication of information to Members.
- (e) To arrange for meetings, forums, and biennial conferences of Members to be held on a regular regional and national basis.
- (f) To formulate policy on such matters as the Association deems proper.
- (g) To liaise with kindred organisations in overseas countries, particularly, with the Club Management Association of America and Golf Management Australia.
- (h) To facilitate the further formal education of Members to enable them to be more proficient in their work.

#### Clause 6

### 6.0 Affiliated Branches

### New wording in bold

The Executive shall encourage Members to hold regular meetings of Members within their regional areas. These areas may be of any size that enables Members to meet together without excessive travel or cost to the Members.

The Executive shall authorize the Members in Districts to form Affiliated Branches to enable those Members to arrange their own activities. There shall not be more than **six** Affiliated Branches. The Branches shall be named "Golf Managers Association of New Zealand Incorporated .......Branch."

These branches may organize their own affairs within the following guidelines:

- Activities of the Branch should only be made available to those Persons who are Members of this Association.
- The Branch shall encourage eligible Persons to join the Association.
- A Branch shall be responsible for its own finances.
- This Association shall have no legal liability in respect of any activity undertaken by a Branch, including financial liability.
- 5. The Branches shall elect representatives to form the Executive of this Association annually.
- Voting for branch representatives will be in accordance with Clause 7 and only members of said branches will be entitled to vote for the representative of that branch.

#### Clause 8 Executive

### New wording in bold

The governing body of the Association shall be an Executive.

- 1. The Executive shall consist of up to eight (8) members, shall be made up of one elected representative of each of the following branches and strive to include at least two women.
- Northern branch
- Waikato branch
- Bay of Plenty branch
- Central branch
- Northern South Island branch
- Southern South Island branch

### Plus, two (2) independent directors appointed at each Annual General Meeting.

If there are less than **eight (8)** Members appointed by Branches, Ordinary Members may be elected to the vacancies by the Members present at the Annual General Meeting.

- 2. The term of office for the Executive shall be two years, commencing from the conclusion of an Annual General Meeting until the conclusion of the Annual General Meeting two years later. Any retiring Executive shall be eligible for reappointment.
- 3. The Executive shall elect from among its Members a Chairperson.
- 4 The Executive may appoint an Executive Officer of the Association.
- 5. The Executive Officer will be the Secretary of the Association.
- 6. The registered office of the Association will be the address of the Executive Officer.

#### 9.0 Powers and Duties of the Executive

### New wording in bold

Add in new sub clause 10.

10. The Executive shall set subscriptions.

### 12.0 Annual General Meetings

### New wording in bold

- An Annual General Meeting of Members must be held in each calendar year and must be held prior to 31 October each year.
- 2. The business to be conducted at the Annual General Meeting shall include:
  - a) Consideration of the Annual Report of the Executive.
  - b) Consideration of the annual Statement of Income and Expenditure of the Association.
  - Election of Members to fill any vacancies on the Executive being Branch representatives and ordinary members
  - d) General Business.

### 13.0 Subscriptions and Finance

#### New wording in bold

- 1. The financial year of the Association shall end on 30 June each year.
- The Association year shall be deemed to commence on the first day of July in each year and an annual subscription shall entitle a member to the privileges of the Association for his or her membership until the last day of June next following.
- Annual Subscriptions shall be set by the Executive.

The changes to the Constitution were adopted unanimously by a show of hands.

### **Election of Officers**

The Golf Managers Association of New Zealand (GMA) Executive Board comprises SEVEN (7) ordinary members including FIVE (5) representatives appointed by their branches.

Ian Litchfield retires as General Manager Pukekohe Golf Club effective 31 January 31, 2022, and has indicated a wish to retire from the Executive after 5 years of Service.
