PAYMENT

A 50% deposit plus GST payment is payable for each partnership and / or exhibition package ordered at the time of application. This payment is required within one month after the issue of the deposit invoice. On receipt of the deposit payment, a letter of confirmation will be provided which secures your partnership package. The final outstanding amount must be paid in full by **20 April 2021** and an invoice for this total will be issued in **March 2021**.

CANCELLATION & WITHDRAWAL

Partners and Exhibitors are required to inform the GMANZ/NZGCA organizers - eo@gmanz.co.nz as soon as possible if they wish to cancel their partnership or exhibitor package. Cancellation will only become effective upon receipt of written notice from the Partner or Exhibitor. Cancellation by a Partner or Exhibitor will result in the following:
